Preview of June 11 Common Council Meetings

Starting at 6:45 P.M. on Tuesday, June 11, the Mequon Common Council, meeting as the Committee of the Whole, will receive an update regarding the Southern Ozaukee Fire & EMS Department. Starting at 7:30 P.M., the Common Council will hold its monthly meeting for June. The Common Council will consider a number of other items, including:

- Repealing and recreating Article XI within the Municipal Code, as it relates floodplain zoning
- Disallowing the claim of Zachariah Anderson dated May 21, 2024
- Appointing Brenda Arnett to the position of Finance Director/City Treasurer as of July 1
- Awarding a Design Services Contract for the City Brush Site to The Sigma Group in the amount of \$84,914
- Approving an Intergovernmental Agreement between the City of Mequon and the City of Milwaukee, in connection with the provision of law enforcement support services during the 2024 Republican National Convention
- Ratifying replacement of a public sanitary sewer lateral at 11333 North Port Washington Road with Grunau in the estimated amount of \$60,000
- Authorizing staff to file the City's Compliance Maintenance Annual Report (CMAR) for Calendar Year 2023, in accordance with requirements under Wisconsin Administrative Code NR208

Mequon Road Town Center Work Update

We Energies is currently performing a project along the Mequon Road corridor to bury electrical lines on the south side of Mequon Road and near the City Hall driveway. The electrical burial project is currently scheduled to conclude in late summer. Additionally, the City's Mequon Road/OIT Crossing Improvements Project has a few items left for completion in 2024, including the following:

- Landscape plantings and restoration
- Median light installation
- Monument sign installation
- Electrical and traffic signal underground work

Activation of the new Weston Drive traffic signals

Most work will be completed this summer. Some electrical and signal work will be completed in late summer 2024 in coordination with WisDOT and the Railroad for activation of the Weston Drive traffic signals. Since the new Weston Drive signals are near the railroad, special safety and timing features need to be set up by the railroad prior to their full operation.

Sanitary Sewer System Bypass Pumping Occurrence on June 3

Starting at 7:45 P.M. on Monday, June 3 until 1:45 A.M. on Tuesday, June 4, a series of wet weather events resulted in inflow and infiltration of clear water into the City's sanitary sewer system. This resulted in surcharging within the sanitary sewer system. Wastewater staff monitored the flow throughout the evening and ultimately bypass pumped at Lift Station H (2932 Riverland Drive). Given the timeline of the bypass and the location of the lift station within the Milwaukee River watershed, which is in close proximity to the river, exposure to the public was limited. Bypass pumping at lift stations is a mitigation strategy to reduce or eliminate sewage backups into basements, which appeared to be successful for this event. Wastewater staff will file the appropriate compliance documents with the WDNR and continue to implement capital projects to further reduce the risk of sanitary sewer overflows.
